Program activities center upon the gathering, handling, and distribution of donated and purchased food commodities and household goods. These core activities are conducted in partnership with retailers, distribution centers, pantries and feeding sites in our service territory. Our programming also includes complementary services targeted to special populations such as children and seniors, along with benefits enrollment activity designed to enhance food access.
